"Approving the Implementing Rules and Regulations of Republic Act No. 10395, also known as An Act Strengthening Tripartism"

WHEREAS, Republic Act No. 10395 or An Act Strengthening Tripartism, Amending for the Purpose Article 175 of Presidential Decree No. 442, As Amended, Otherwise Known as the Labor Code of the Philippines was signed into law by President Benigno S. Aquino III on 14 March 2013, which is a realization of the tripartite commitment in the Philippine Labor and Employment Plan (PLEP) 2011-2016 to strengthen and institutionalize tripartism and social dialogue by amending Article 275 of the Labor Code;

WHEREAS, R.A. No. 10395 prescribed the representation of workers and employers in decision and policy-making bodies of the government and institutionalized the TIPC at the national, local and industry-based levels for such purpose;

WHEREAS, pursuant to Section 2 of R.A. No. 10395, the Department of Labor and Employment, together with the tripartite partners, drafted the Implementing Rules and Regulations of R.A. No. 10395 which had been deliberated and approved by the Tripartite Executive Committee (TEC) on 19 September 2013;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED TO approve the IRR of Republic Act No. 10395, for immediate issuance by the Secretary of Labor and Employment.
